

4. The incomplete application and **those received after 05.00 PM of due date i.e. 06.11.2020** shall be rejected without assigning any reason. This office will not be responsible **for any postal delay or wrong delivery, whatsoever.**
5. Before applying to the above said posts, candidate should ensure that he / she fulfills eligibility criteria. This office shall reject the applications not fulfilling the requisite criteria at any stage of recruitment and if erroneously appointed such candidate shall be removed from service.
6. The reservation of vacancies is as per the policy of Punjab Government. If no suitable candidate from the reserved category is found available, the post of reserved category will be offered to the candidates of General Category.


