I. COMPANY PROFILE

KIOCL Limited was incorporated under the Indian Companies Act, 1956 with the objective to mine low grade Magnetite Iron Ore & beneficiate the same for further use. The Company is currently operating 3.5 MTPA Iron Oxide Pellet Plant and has Blast Furnance Unit to manufacture 2.16 lakh tonne per annum Pig Iron at Mangalore, Karnataka. KIOCL is a schedule - 'A' Mini Ratna CPSE in the Mineral and Metals sector with the administrative jurisdiction of Ministry of Steel. The company employed 805 regular employees (Executives 260 & Non-Executives 545) as on 31.03.2020.

The authorized and paid up capital of the Company was Rs. 675 crores and Rs. 621.92 crores respectively as on 31.03.2020.

Its Registered and Corporate office are at Bangalore, Karnataka.

The shareholding of the Government of India in the company is 99.06%. However, the Government has approved disinvestment of 15% equity shares of KIOCL.

II. JOB DESCRIPTION AND RESPONSIBILITIES

The Chairman and Managing Director is the Chief Executive of the Corporation and accountable to its Board of Directors and Government. He/She is responsible for the efficient functioning of the Corporation, and for achieving its corporate objectives and performance parameters.

III. ELIGIBILITY

Applicants with experience in Finance/Marketing/Production will have an added advantage. Experience in Iron/Steel sector is desirable.
