2. The essential eligibility criteria for the aforementioned post are as under:-

- (i). holding analogous post on regular basis in the parent cadre or department; **or**
- (ii). with three years of regular service in Level – 10 of the Pay Matrix; **and**

**(b) Possessing the following essential educational qualifications and experience:-**

- (i). First Class Master's Degree in Science in Physics or Electronics or Mathematics from a recognised University or Institute; **or**  
First Class Bachelor's Degree in Engineering or Technology from a recognised University or Institute;
- (ii). Three years of Research or Design or Development or Technology Application or Operational Experience in Computer programming/ Automation/ Technical Data Analysis/ Software Development/Network Engineering/ Network Management/ Network Development/ Communication Network/ Setting up of advanced IT infrastructure/ Data Communication Network Management/ Cyber Security/ Remote Sensing/ Cryptology/Cyber Forensics/ Artificial Intelligence/ Data Analytics or any other area which has relevance and is found suitable for the organisation;
- (iii). Knowledge of Computer Application

**Note-1:** The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment on promotion.

**Note-2:** The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed four years.

**Note-3:** The maximum age limit for appointment on deputation shall be not exceeding 56 years as on the closing date of the receipt of the application.

### **For Ex-Serviceman: Deputation/Re-employment**

The Armed Forces personnel due to retire or who are to be transferred to reserve within a period of one year and having the requisite experience and qualifications prescribed shall also be considered. Such persons would be given deputation term upto the date on which they are due for release from the Armed Forces; thereafter, they may be continued on re-employment.
