## I. COMPANY PROFILE

Western Coalfields Limited (WCL) was incorporated under the Indian Companies Act, 1956 with the objective to reorganise the nationalised Coal Industry and to produce coal efficiently and economically with due regard to safety, conservation and quality. WCL is a subsidiary of Coal India Limited. It is a schedule-'B' Mini ratna CPSE with the administrative jurisdiction of Ministry of Coal. The company employed 40401 regular employees (Executives- 2214 & Non-executives- 38187) as on 31.03.2020.

Its Registered and Corporate Offices are at Nagpur, Maharashtra.

The authorized and paid up share capital of the Company was Rs. 800 crore and Rs. 297.10 crore respectively as on 31.03.2020.

WCL is a wholly owned subsidiary of Coal India Limited.

#### II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Technical) is a member of the Board of Directors of WCL and reports to Chairman and Managing Director. He/She is responsible for operation of mines and also of field activities, technical functions and safety of mines.

## 3. QUALIFICATION:

The applicant should be a qualified Mining Engineer and holder of 1st class certificate of competency under the Indian Mines Act.

## 4. EXPERIENCE:

The applicant should have at least eight years' cumulative experience during the last ten years in Mining Operations or Mine Planning at a senior management level in an organization of repute.
