

REGIONAL CENTRE FOR BIOTECHNOLOGY (RCB), FARIDABAD (An Autonomous Institution of Department of Biotechnology, Ministry of Science & Technology, Government of India)

The Regional Centre for Biotechnology (RCB) is an institution of Education, Training & Research which is established by the Department of Biotechnology, Government of India, under the auspices of UNESCO. As per the agreement signed with UNESCO, the Centre is a Category-II Institution under the auspices of UNESCO in terms of "Principles and Guidelines for the Establishment and Functioning of UNESCO institutes and Centres". The Centre is the first ever interdisciplinary institution in life sciences and biotechnology in India. It is a regional hub for interdisciplinary education and training with emphasis on novel education programmes relevant to industry, including bio-drug discovery science, nano-science & medicine, imaging techniques, designer crops, bioengineering and biomaterials, intellectual property, technology transfer and regulation to fulfil and overcome the acute shortage of skilled human resources in India. It would also act as the focal point for cooperation amongst the member countries of the Asian Region in Biotechnology and is governed by a Board of Governors with representations from India, UNESCO and the member countries. Collaboration with UNESCO which ensures gateways to international institutions such as European Molecular Biology Organization (EMBO), International Union of Biochemistry & Molecular Biology (IUBMB) etc. and usher in skill acquisition in the global context. Applications / Nominations are invited from Indian Nationals for the post of 'Executive Director', Regional Centre for Biotechnology (RCB), Faridabad. The position offers a unique opportunity to those willing to take up a challenging assignment and provide dynamic leadership in scientific, academic and administrative matters relating to the institute. The candidate is expected to establish RCB as a world class research institute and guide multi-disciplinary research teams.

1. Eligibility Criteria

Scientists from Central / State Governments, Research Institutes, Autonomous Bodies, Government funded Research organizations / Institutes etc.

- (i) Holding analogous post on regular basis in the parent Department' or
- (ii) With 5 years service in post with Pay Matrix Level-14 (as per 7th CPC) or equivalent in the parent cadre/Department and possess the qualification & experience as below:-

2. Job Specifications

- (i) To provide academic and administrative leadership to the institute.
- (ii) The post carries the pay of Rs. 2,10,000/- (Fixed) with the existing special allowance of Rs. 11,250/- per month and usual allowances as per Govt. of India Rules on Deputation (ISTC)/Deputation.
- (iii) The period of Deputation includes period of deputation in other ex-cadre posts, held immediately preceding this appointment in the same or other organization / Department should ordinarily not exceed 5 years. The maximum age limit for appointment on deputation (ISTC) should not exceed 60 years for Deputation and 65 years for Contract as on the closing date of receipt of applications.

3. Qualifications

Essential:

- (i) Ph.D. /MD or equivalent degree and excellent track record with peer reviewed publications.
- (ii) Minimum 15 years of research experience as independent investigator of Biotechnology/Life Science and related areas.
- (iii) Global network of scientific contacts in the field of biotechnology.
- (iv) Ability to command respect of the academic and the user communities across the domain of biological sciences through personal achievements in research and standing in the field.

Desirable:

- (i) A creative personality with strong leadership and managerial skills with efficiency and probity.
- (ii) Capacity for lateral thinking for finding new approaches to multidisciplinary research, education & training for value addition to the Centre's programmes.

4. General:

- (i) The applicants in Central/State Government organizations / Public Sector Undertakings / Autonomous Organizations must send their applications "Through Proper Channel". The applications received without the recommendations of the employers will not be considered.
- (ii) The date of determining the age limit shall be the closing date for receipt of applications.
- (iii) The Executive Director shall hold the office for a term of five years from the date on which he enters upon the office, or until he attains the age of seventy years, whichever is earlier, and he/she shall be eligible for re-appointment on completion of the tenure provided that notwithstanding the expiry of the said period of five years, he/she shall continue in office until his/her successor is appointed and enters upon his office.
